**Speed Hump Discussion:** Ian Golden provided an update on the speed humps project to the board, as Public Works informed us Mitchell Road will need to be resurfaced prior to installation of said humps. The *estimate* to resurface is \$31,000 (projected total cost \$35,000) which can be funded by CDBG. In order to move the speed humps project forward, Ian will need to complete a Substantial Amendment to bring to the BOCC (Board of County Commissioners) meeting in March for approval. Today, Ian is asking the CDGB Advisory Board Committee to accept the addition of funding for the road resurfacing project; motion to accept by Tony Sasso, seconded by all.

**Community Development Block Grant-CV update:** Ian provided an update on the CDBG-CV dollars that came under Coronavirus Cares Act by HUD. Initially HUD allowed six (6) years to expend the funds; they have now imposed a three-year (3) deadline instead. That said, we only have until July 2023 to spend the CV-funds. We have requested guidance on submitting a waiver twice and both times the response is "HUD Washington has not given guidance to Jacksonville on how to get that waiver". Our plan is to continue to seek a waiver to get the extension.

Additionally, there are other options available to spend the funds vs. losing them, such as purchasing hurricane and disaster sheltering Concentrator machines and Air-Cleaning machines, including the proper chemicals for these machines.

Current agencies that requested funding (or are requesting funding today) will be clear of when final invoice due dates will be accepted in order for us to pay them appropriately by the final date, which is end of July. Contracts will be retro-active to the contract start date (date contract signed) so they can bill us from that day forward. Art Edwards requested the board be informed of how the progress is going to ensure the agencies are able to complete their obligations of the contracts. Ian stated he will have Lesley's staff (Contracts Team) email the board with updates. Ian also reiterated the time frame issue is HUD imposed.

### **RFP's: Public Services Recommendations:**

The County Received \$205,815.75 in CDBG Public Services funding for fiscal year 2023.

Board Members asked questions and requested clarifications on items for a full understanding of how these funds will be used and tracked from participating agencies. The results of the Board Members recommended approval for funding is listed as follows:

Emma Jewel Charter Academy- Transportation: \$48,439.80, Brevard Alzheimer's – Safe Ride- \$42,500.00, AMI Kids Space Coast-Education Program- \$20,000.00, Family Promise- Shelter- \$25,740.00, Helping Seniors of Brevard- Navigation- \$30,000.00, Grandparents Raising Grandchildren- Child First- \$21,020.30, Life Recaptured- Case



Management- \$18,115.65. Final Approved CDBG- Public Service Funding Recommendations - \$205,815.75.
